

# Welcome to Singapore

## For Short Term Visitors from India using Vaccinated Travel Lane (VTL) Flights

### What you need to know

A handy guide to travelling to Singapore, including useful checklists, key documents required for travel and an overview of what to expect at different stages of your travel journey.



## Pre-Departure Checklist

### Eligibility Criteria



#### Be fully-vaccinated with WHO-EUL vaccines\*

#### Vaccination certificate stating:

- The traveller's name, passport number and date of birth
- Country/region of vaccination which must be either Singapore or a VTL country/region
- Name of vaccine used
- Dates of vaccination
- A QR code that can be digitally authenticated by immigration authorities



#### Been in India or any other VTL country for the last 7 consecutive days before departure to Singapore

\* An individual is considered fully vaccinated 14 days after he/she has received the full regimen of a WHO-EUL vaccine.

\*\* The following travellers do not need to apply for a VTP while travelling on VTL:  
 (1) Non vaccinated children aged 12 and below who are accompanied by an adult.  
 (2) Singapore Citizens, Permanent Residents and Long Term Pass Holders (excluding Work Permit).

\*\*\* Children aged 2 and below in the calendar year and vaccinated travellers that are recovered from Covid-19 infection with an authorised medical discharge certificate (Proof of Recovery) are exempted from all tests in Singapore after arrival. For more information, see:

\*\*\*\* Short-Term Visitors can obtain TT tokens with a payment of S\$13 per token, from the Singapore Visitor Centre at Orchard Gateway, or any of the TT Token collection booths found at community centres. For more information, see:

## Actions Required



#### Apply for a Vaccinated Travel Pass (VTP) 3 to 60 days in advance of intended date of departure\*\*

Apply for visa where applicable with Authorised Visa Agents (AVA) after obtaining VTP.

#### Book a ticket on designated VTL flights



#### Take a pre-departure PCR test\*\*\* from an accredited/authorised testing facility or professionally-administered ART within 2 days before departure.

 The result should contain:

- The traveller's name, passport number and date of birth
- A negative COVID-19 PCR test result or professionally administered Antigen-Rapid-Test (ART)
- Date and time of the test
- Name of testing institution

# In Transit

## Guidelines during travel:

- A face mask must be worn throughout the duration of your flight except when eating or drinking
- Observe your respective airline's advice regarding inflight rules and conduct of passengers

# Upon-Arrival



**Purchase of SIM cards** can be done in transit area prior to clearing arrival immigration.



**Documents required to be shown to Immigration & Checkpoints Authority:**

- A valid Vaccinated Travel Pass
- COVID-19 travel insurance
- Vaccination certificate
- A valid pre-departure COVID-19 PCR test or professionally administered ART\*\*\*
- A valid visa where applicable
- Proof of Recovery where applicable

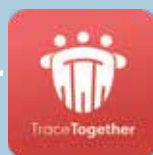


**Take a supervised self-swap ART within 24 hours after arrival at one of the testing centres. \*\*\***

You may carry on with your activities after receiving a negative test result.

# While out and about in Singapore

- Wear a face mask at all times
- Adhere to prevailing rules regarding social gatherings (includes dining at F&B outlets)
- Use TraceTogether app/token to check-in and out of establishments
- As some attractions are required to stagger entries as part of their Safe Management Measures (SMMs), it is recommended that entry to ticketed attractions be booked in advance



Keep TraceTogether app data for 25 days after leaving SG, to facilitate contract tracing and quick follow-up in the event of exposure to the virus



Before returning home, remember to check and abide by your airline and local government's prevailing entry requirements.
